ORDER

In terms of Section 14(1) of the NCTE Act, 1993 **TMAE Society, Harapanahalli, Haveri District, Karnataka** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **TMAE Society's B.P.Ed College, Igari Lakmapura, P.B.Road, Haveri-581110, Karnataka** for B.P.Ed Course of one year duration from the academic session **2005-06** with an annual intake of **50** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.
 - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs.1.89 lakhs.
 - d. The institution has selected the **Principal and three** lecturers for the said course.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **TMAE Society's B.P.Ed College, Igari Lakmapura, P.B.Road, Haveri-581110, Karnataka** for B.P.Ed course of one year duration from the academic session **2005-2006** with an annual intake of **50** students subject to fulfillment of the following.
 - a. The institution will ensure that **Principal and three** faculty members duly approved by affiliating University are in position for an intake of **50** students before commencement of admissions and a copy of approved staff list shall be sent to the Southern Regional Committee immediately and in any case before commencement of the admissions.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - c. The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. AND WHEREAS, the institution **TMAE Society's B.P.Ed College, Igari Lakmapura, P.B.Road, Haveri – 581110, Karnataka** has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.

3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 100 students(two sections of 50 each) subject to the institution fulfilling following conditions namely,

- I. The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
- II. The institution shall appoint additional staff as per Regulations, 2014 and submit approved staff list to the Regional Committees with required documents by October 31, 2015.
- III. The Regional Committees shall arrange for verification of documents, check adherence by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with the new teaching staff requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.

5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE, Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **TMAE Society's B.P.Ed College, Igari Lakmapura, P.B.Road, Haveri – 581110, Karnataka** for conducting B.P.Ed programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and appointment of staff as per Regulations 2014 before 31.10.2015.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.



8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.


